The University Academic Council (UAC) meeting was convened at approximately 3:05 p.m. on Thursday, February 15, 2007, with Dr. Michael L. McFrazier, Associate Provost for Academic and Student Affairs, presiding. The meeting location was the Memorial Student Center Conference Room, 203. Dr. McFrazier welcomed everyone present and asked the guest present to introduce themselves.

### **I. Approval of UAC minutes of January 25, 2007**

**Motion:** Mr. Wood and Dr. Booker seconded the motion that the UAC minutes of January 25, 2007 be approved as read with two name corrections. **The motion carried unanimously.**

### **II. Course Inventory Updates/Proposals**

- **Mr. Peter Wood, Chair, UAC Task Force I  
Submissions from College of Arts and Sciences  
Department of Physics**

Mr. Wood indicated that the committee reviewed the Department of Physics submissions and concluded that they were in compliance with what was requested of the UAC Review Task Force. Mr. Wood asked Dr. Kumar to share comments on non-substantive Course Inventory Updates submitted by the Department of Physics. Dr. Kumar was requesting the following approvals: (1) Approval to reduce the number of Semester Credit Hours in the Bachelor of Science in Physics degree from 125 SCH to 120 SCH; (2) Approval to introduce four new courses in the Department of Physics: PHYS 4163 (Special Topics in Physics); PHSC 4163 (Special Topics in Physical Science); PHSC 3083 (Science of Everyday Life) and PHSC 3183 (Modern Physics for Science Teachers); and (3) Approval to introduce a Bachelor of Science degree in Physics with a concentration in Physical Science.

**Motion I:** Mr. Wood moved and Dr. Hansen seconded the motion to approve the reduction in the number of semester credit hours in the B.S. in Physics degree from 125 SCH to 120 SCH. **The motion carried unanimously.**

**Motion II:** Mr. Wood and Dr. Hansen seconded the motion to approve the introduction of four new courses into the Department of Physics. **The motion carried unanimously with corrections.**

**Motion III:** Mr. Wood moved and Dr. Quddus seconded the motion to table the request to approve the introduction of a Bachelor of Science degree in Physics with a concentration in Physical Science for further discussion. **The motion carried unanimously.**

Submissions from College of Business**

Mr. Byars indicated that the committee reviewed the College of Business submissions and concluded that they were in compliance with what was requested of the UAC Review Task Force. Mr. Byars asked Dr. Tandon to share comments on non-substantive requests. The College of Business was requesting approval to include MISY 2013 (Fundamentals of MIS) to the core and approval to introduce a new program titled “The Certification in Entrepreneurship”.

Submissions from College of Engineering**

Dr. Booker indicated that Task Force IV had reviewed the College of Engineering submissions and stated that they were in compliance with what was requested of the UAC Review Task Force. Dr. Harris addressed the council on behalf of Dr. Shield Lin. After satisfying a few concerns of the council, the courses were approved.

**Motion I: Dr. Booker moved** and Dr. Stanley seconded the motion that the College of Engineering courses (ELEG 3063; 4303; 3071; 3073; 4253; 4393 and 4333) be approved as submitted. **The motion carried unanimously.**

- Mr. Wood indicated that the McFrazier indicated that the request from the College of Business was to establish a formal partnership with the Cy-Fair College. He indicated that the request was being presented as an urgent agenda consent item due to the Northwest Houston corridor issues that have evolved. He stated that the UAC has the support of the Provost and Ms. Verna Dewees. Thereafter, Dr. McFrazier asked Dr. Quddus to give the Council an overview of the proposal.
- Dr. Quddus indicated that the College of Business was requesting approval to offer a PVAMU - Cy-Fair College Joint Admissions On-Site Program at the Cy-Fair College (Barker Cypress), effective summer 2007. He indicated that students enrolled in a NHMCCD campus would be able to obtain a Bachelors of Business Administration (BBA) Degree (Finance, Management, MIS) onsite. This option would also be available via distance education and TTVN. He stated that the proposal was approved by the Board of Regents and stated that there was no other four year program existing within the system. He concluded by stating that the program would be a great benefit to the University.
